A greater limit of liability is available upon payment of an additional charge per shipment for insurance to be quoted by Dutch Express at the time of the call by client or shipper, unless a higher value is declared, and the additional insurance charge paid, in no event will Dutch Express liability exceed \$500.00. In particular, but not in limitation, with respect to loss, misdelivery, destruction or damage from any cause to fashion or designer clothes, fur's, jewelry, negotiable securities or other high value items, Dutch Express will not be liable for more than the above limit unless a call is placed with the main office (212-717-5555), the nature and value of such items are declared, insurance obtained for the declared value and Dutch Express is afforded a reasonable opportunity to adequately protect the shipment. Dutch Express shall not be liable for damage or delay caused by incorrectly labeled or inadequately wrapped or packaged shipments. Claims regarding loss or damage of any kind must be made in writing to Dutch Express within seven (7) days of delivery of shipment. Claims not made within seven (7) days of delivery shall be deemed waived by the client or shipper. Should any claim in an amount excess of the foregoing limit of liability be asserted against Dutch Express by third party for loss or damage to merchandise handled hereunder, the client or shipper agrees to hold Dutch Express harmless against any such claims, including attorney's fees, irrespective of the cause of loss or damage. In no event shall Dutch Express be liable for special, exemplary or consequential damages or loss of profits or business losses even if such contingency is made known to Dutch Express prior to shipment.
